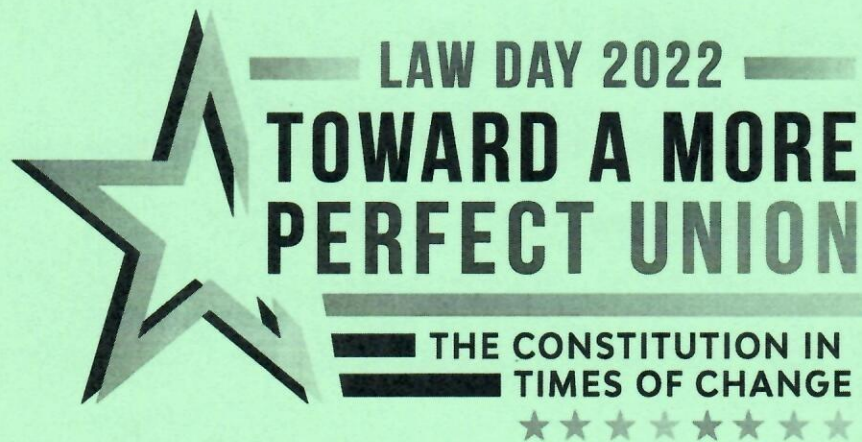

The Stark County Bar Association is asking your school to participate in our sixth annual Digital Media Contest held as part of our Law Week Celebration.


