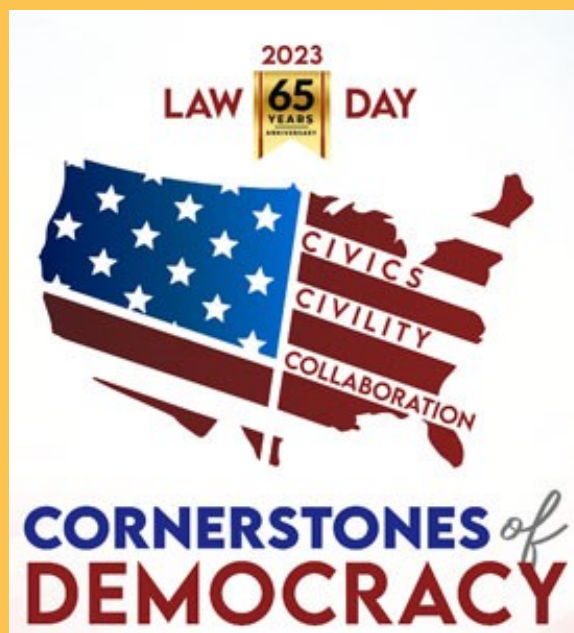

The purpose of this letter is to invite your students to participate in the Moot Court Competition to be held on Monday, May 1, 2023.


