



In 2023 we took the opportunity to recognize local practitioners who were celebrating 50 years in the practice of law. Our last attorney for 2023 to be recognized for a largely commendable 50 years of practice is John B. Wirtz, Esq.

50тн Year Spotlight

John B. Wirtz, Esq.



Pop Quiz: How many members of the Stark County Bar Association are also airplane pilots? While I do not know the answer to this question, I do know the answer is greater than or equal to one.

Attorney John B. Wirtz first obtained his pilot's license at the age of 17 while he was working for Teledyne-

Monarch, which was located off Route 43 just north of Hartville. Thereafter, he went to work at Southwest Bank in St. Louis, Missouri while he attended St. Louis University in pursuit of his bachelor's degree.

During his undergraduate education, all of John's roommates were planning to attend postgraduate and professional studies, and one of them informed Attorney Wirtz of his desire to attend law school. This prompted Attorney Wirtz to conclude: "If he's going to be a lawyer, I am too!" He then set about applying to law schools.

Although he was accepted to each of the law schools that he applied to, as a Stark County native and graduate of Central Catholic High School, Attorney Wirtz decided to attend Case Western Reserve University to be closer to his hometown.

With no job prospects on his horizon, Attorney Wirtz heard that the Stark County Prosecutor's Office was hiring and he contacted Stark County Prosecutor David Dowd to inquire. To his surprise, he was not required to abide by any formalities in applying for a position as an Assistant Prosecutor, such as submitting a job application, and instead was told he would start the following week.

While working at the Stark County Prosecutor's Office, Attorney Wirtz found a niche for himself in the Civil Division handling Board of Tax Appeals and Board of Revision matters. Through his work at the Prosecutor's Office, Attorney Wirtz represented county offices and agencies in many high-profile cases, including property disputes related to the burgeoning Belden Village Mall. Given the fact that many such cases (Board of Tax Appeals) are directly appealable to the Ohio Supreme Court, Attorney Wirtz frequently found himself litigating before the State's highest court.

Recalling one of his most prominent cases while working at the Prosecutor's Office, Attorney Wirtz described the Penn Central bankruptcy, which was, at the time, one of the largest corporate bankruptcies in the history of the United States. When Penn Central filed for bankruptcy protection, they owed many thousands of dollars in taxes to Stark County. By partnering with an attorney from Philadelphia, Attorney Wirtz remained steadfast in his position that Stark County was entitled to be repaid 100% of what it was owed. Eventually, his drive and determination paid off, as the County's claim gradually moved from the bottom of the creditor priority list to the top, where the County's debt was eventually repaid in full.

Attorney Wirtz's work at the Prosecutor's Office also allowed him to develop client relationships with entities that would later become private clients when he chose to leave the Prosecutor's Office. Among these were many clients that Attorney Wirtz would continue to represent throughout his career, including Stark Metropolitan Housing Authority and the Stark County Education Service Center, where he formed a close bond with well-known former superintendent Larry Morgan. Through this work, Attorney Wirtz assisted in handling very contentious labor disputes and is credited with prevailing in a claim against Cleveland Clinic in excess of \$1 million dollars that was owed to Stark County schools. Although his representation was of great importance and significance, Attorney Wirtz often preferred to maintain a low profile. "Never get into an argument with someone who buys ink by the barrel," Attorney Wirtz noted.

Given his interest in aviation, Attorney Wirtz once approached then-County Commissioner Dr. Peter Ferguson about becoming involved with the Akron-Canton Airport. Many people are unaware that the Akron-Canton Airport is the only commercial airfield in the State of Ohio governed by an airport authority, which is a political subdivision of the State. This led to Attorney Wirtz being appointed to the Akron-Canton Airport Board of Trustees, a position that he has repeatedly been reappointed to and where he remains to this day. Attorney Wirtz is also an avid kayaker and can often be found paddling around Meyers Lake, where he resides and serves on the Meyers Lake Preserve Committee, which oversees ownership/stewardship of the body of water known as Meyers Lake. Additionally, Attorney
