The Stark County Bar Association is asking your school to participate in our annual Poster Contest held as part of our Law Week Celebration.



There are three categories: *Kindergarten – 2<sup>nd</sup> grade*; *3<sup>rd</sup> – 5<sup>th</sup> grade*; and *6<sup>th</sup> – 8<sup>th</sup> grade*, **CHECK PRIZE FOR EACH CATEGORY**. First Place Prize in each category is **\$50.00 check**; Second Place Prize in each category is **\$40.00 check** and Third Place Prize in each category is **\$20.00 check**. All of the winning students in each division will be recognized on our website.

### ELIGIBILITY:

Any student in the Public, Parochial, or Private Schools of Stark County is eligible to participate in the contest, from kindergarten through 8<sup>th</sup> grade. Categories will be as follows: Kindergarten - 2<sup>nd</sup> grade; 3<sup>rd</sup> - 5<sup>th</sup> grade; and 6<sup>th</sup> - 8<sup>th</sup> grade. Each student may submit only **ONE INDIVIDUAL** entry and the art work must be the original art work of the contestant.

### POSTER SIZE:

Posters must be submitted on standard size 22" X 28" poster board of any thickness. This is the standard size sold by all office and art supply stores and most drug and discount stores.

### PRIZES:

Prizes will be awarded to Individuals in each of the categories:
