#### **From Our President**

## Embrace March Madness

America used to be known for simple things like apple pie, baseball and Mickey Mouse, but now the nation has a new and more popular mania that disrupts our lives and brings forth fleeting emotions of ecstasy, empathy, joy and sorrow. It's also had an enormous impact on the practice of law. Each winter, men and women's NCAA college basketball teams try to survive three weeks of drama with these highstakes matches filled with hour-long final minutes (at least it seems that way) that keep you on the edge of your seat. It isn't even so critical for your team to win it all, but just a trip to the final four brings thrills to those whose players get hot at the right time and survive to the final weekend. It's epic, gripping, with a cast full of colorful players and coaches. The tournament is unmatched in sports when it comes to drama.

#### Tips for Bracket Selection

## **50тн Year Spotlight**

## John A. Tscholl, Esq.



Let's start with how you became an attorney, give us the background.

I really never thought of another occupation. My father was an attorney and I knew that's what I wanted to be. I did my undergraduate work at the University of Detroit, majoring in Economics, graduating in 1971. I received my law

degree from The University of Akron in 1974.

When you first graduated law school did you immediately know what area of law you were interested in practicing? Is that the area of law you started in? If not, how did you eventually get to the area of law that you primarily practiced in during your career?

When I was in law school, I interned under Harry Klide in the Canton City Prosecutor's Office. Once, at sentencing, a defendant was given jail time by the Judge. He wasn't happy because he turned and raced out of the courtroom. At that point, John Hoffman, the Prosecutor, ran after him and tackled him in the hallway. I realized, at that moment, that I wanted to be a criminal defense attorney.

#### Did you have any legal mentors you really relied on during your career and how did they help you develop your practice?

One month after passing the bar, I tried my first criminal case. My client was charged with murder. Every day after court during the trial, I went to the Public Defender's Office and spoke with the Director, Gary Procario, and his chief assistant, John Nicodemo, reviewing the day's court proceedings and making a plan on how to move forward. BTW, my client was found Not Guilty.

## What was one of the greatest legal achievements you look back on from your career?

My final criminal trial before Common Pleas Judge John Boggins involved a client who was charged with felony domestic violence against his spouse. Because of his previous conviction of committing domestic violence against her, this charge was considered a felony. The prosecutor was required to inform the jury of the previous conviction of abusing the same person. Although I feel this information would probably bias most juries against my client, he was found Not Guilty.

Is there a legal opportunity you wish you had experienced during your career?


No, there isn't.

## What have been the things you treasure most about the practice of law over your career?

During my practice of law, the camaraderie developed over the years within the legal community has been priceless. The practice of law has enabled me to meet and befriend numerous attorneys and judges over the span of my career. ... Don Little, John Hornbrook, Tom Borcoman, John McCall, Don Miller, John Haas, Bob Rubin, Tom Bernabei, Alan Schulman, Stacy Roth, and Tim Saylor ....to name a few..... And, of course, last but never least, my brother, Bob Tscholl.

Looking back over the last 50 years, what advice would you give a new lawyer with respect to the outlook for their own career?

There are many areas of the law in which to practice. My advice would be to find one that you truly enjoy and make it your passion.



# Legal Avenues: Your Road to Solutions

Do You Have a Legal Reference Question? The Stark County Law Library Can Help.

Have you wondered about the types of questions patrons pose to the Law Library? Our staff receives inquiries about numerous questions throughout the day, with reference questions being the most common requests we receive from both the general public and Law Library members. Reach out to us for assistance in finding answers to **your** queries!

Reference questions can be answered in as little as five minutes or take up to twenty-four hours to be answered, response time depends on how in-depth the question is.

Here are a few examples of reference questions:

**Question 1:** Do you have information on rules and regulations for remote work/out-of-state employees regarding insurance?

**Library Staff:** Several articles discussing OH H.B. 447, which dealt with work from home employees, were emailed. Westlaw Practical Law has a Q&A Tool that includes charts, questions, overviews, and a Multi-State Charts Toolkit.

**Question 2:** Where can I find the International Property Maintenance Code?

**Library Staff:** There are many editions of the International Property Maintenance Code. Many of them can be found on the International Code Council website, although the website does not permit them to be printed. There are also several versions on the library's Westlaw subscription that can be emailed.

**Question 3:** Who would I speak to about a traffic light located in Akron?

**Library Staff:** Information about the Akron Traffic Engineering Division is available on the City of Akron website.. The Ohio Manual of Uniform Traffic Control Devices current version is available on the ODOT site.

**Question 4:** Can you provide jury verdicts and settlements for the amputation of a finger?

**Library Staff:** Provided various jury verdicts and settlements documents.

Law library staff utilize a plethora of research databases as well as government websites to ensure accurate and timely responses. You can inquire about legal reference matters in person, through our website via chat, email, over the phone within the Law Library's operating hours Monday to Friday, 8:30 AM to 4:30 PM.


