From Our President

The SCBA is honored that one of our own colleagues, and more importantly a Judge, has been named the Stark County Veteran of the Year by the Veteran Services Commission of Stark County. Judge Edward Elum will be presented with the medal on Veterans Day, November 11th and he will be nominated for the Ohio Veterans Hall of Fame. Congratulations Judge Elum for a well-deserved honor, and for your service to our country, as well as your professionalism to our community.

My top Veteran, sorry Judge Elum, is my father, Angelo Jack Vagotis. After graduating from McKinley High School in 1941, he along with most other male graduates, were drafted into World War II. On July 20, 1943, my father was one of 3,323,970 Americans inducted that year in the U.S. armed forces fighting for freedom for our country and the rest of the world. He was a construction foreman with rifle sharpshooter specialty. All he ever told us was that he built bridges.

He served in the 1253rd Engineer Combat Battalion in the Rhineland Campaign. My father's battalion received a Commendation from the commanding officer of the 1117th Engineer Combat Group, Ninth U.S. Army, for successfully building a pontoon bridge and approach roads, for 2 ½ miles across the Rhine. The commendation said the "construction of the 2 ½ mile pontoon bridge and roads, referred to as the Rhine River crossing, was considered "one of the great military accomplishments of the war" and it "contributed materially" to the capture of the Rhineland region of Germany.

Due to duties of combat engineers (such as mine removal, road reconstruction, etc., after Germany's May 7, 1945, surrender, my father was in one of the last group of servicemen to return home. He was discharged on March 24, 1946, having received 2 bronze stars. My mother made it known to us that she was growing tired of waiting for him to return, because so many other servicemen had already returned home and wed their sweethearts. My mother waited for my father and they were married on August 25, 1946.

Like many WWII veterans, he did not speak about his time in the war. My father did say when he returned to America, that he vowed "that he would never leave American soil again." He held true to this. Fortunately, there are still members of the Bar Association who knew my father from working out daily at the original Canton YMCA. This was his home away from home and ulti-

mately, he died suddenly there on his birthday, April 11, 1989. He missed my law school graduation by less than one year.

I'm sure many of you have stories of your loved one's years of service. Take the time in the weeks to come to honor them by sharing those stories. There are numerous Veterans Day events for you to participate in. The Veterans Service Commission of Stark County and the SAMS Center have them listed on their website. If you would like to obtain your loved one's service records, you can request it at the *National Personnel Records Center*, www.archives.gov.

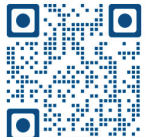

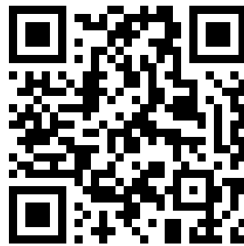
