## *“There Ought To Be A Law”*

### 2025 Essay Contest - Guidelines & Rules

The Stark County Bar Association is once again sponsoring the annual Law Day Essay Contest project. Focusing on how laws are developed, the project asks 7<sup>th</sup> through 12<sup>th</sup> grade students to write about what they believe *“There Ought to be a Law”*. Each student is asked to generate an idea for a new law and provide reasons why that particular law should be enacted, taking into account its impact on the community.

#### Guidelines:

Each student who wishes to participate must write an essay of 1,000 words or less proposing a new rule or law to be enacted in Ohio at the school, community, county, or state level. Proposed, pending, or current legislation may be used for topic ideas, but the student-generated laws should be original. Because this contest is designed to foster creative thinking, each essayist is asked to adhere to the following guidelines:

- Propose an original law that to the student’s knowledge is not currently in effect in Ohio.
- Use for topic ideas, but do not copy, any proposed or pending legislation.
- Fully explain the proposed law by:
  - clarifying what the law would create or change;
  - exploring the benefits and consequences of the proposed law;
  - anticipating the proposed law’s impact on existing rules or laws as well as the law’s impact on those who would be affected;
  - explaining why the law needs to be created and how it would be enforced;
  - telling when and where the law would be effective.

**Rules:**

All essays should be typewritten in a 12-point font and include:

- The student's name, address, phone number, age, and grade level;
- Completed parental release form (if under 18 years of age);
- School name, address, phone number, and teacher's name.
- Student's E-mail address.

Prizes will be awarded for each division, as follows:

1. The William A. Summit and Dorothy J. Summit Memorial Award for the Outstanding Essay \$ 250.00 check
2. First Prize for each division \$ 50.00 check
3. Second Prize for each division \$ 40.00 check
4. Third Prize for each division \$ 20.00 check

All of the winning students in each division will have their essay recognized at the Stark County Courthouse Open House in May and at the Cyrus Custom Framing & Art this Fall.
