“**The Constitution’s Promise: Out of Many, One**” is the theme for the Law Day 2025 Poster Contest. Any student enrolled in public, parochial, or private schools in grades kindergarten through eight is eligible to participate. There are three categories: *Kindergarten – 2<sup>nd</sup> grade*; *3<sup>rd</sup> – 5<sup>th</sup> grade*; and *6<sup>th</sup> – 8<sup>th</sup> grade*, **CHECK PRIZE FOR EACH CATEGORY**. First Place Prize in each category is **\$50.00 check**; Second Place Prize in each category is **\$40.00 check** and Third Place Prize in each category is **\$20.00 check**. All of the winning students in each division will have their poster recognized at the Stark County Courthouse Open House in May and at the Cyrus Custom Framing & Art this Fall.

An entry form is enclosed to which the Rules of Competition are set out. Please have the student complete this form and attach it to the back of the poster being submitted.

### **ELIGIBILITY:**

Any student in the Public, Parochial, or Private Schools of Stark County is eligible to participate in the contest, from kindergarten through 8<sup>th</sup> grade. Categories will be as follows: Kindergarten - 2<sup>nd</sup> grade; 3<sup>rd</sup> - 5<sup>th</sup> grade; and 6<sup>th</sup> - 8<sup>th</sup> grade. Each student may submit only **ONE INDIVIDUAL** entry and the art work must be the original art work of the contestant.

### **POSTER SIZE:**

Posters must be submitted on standard size 22" X 28" poster board of any thickness. This is the standard size sold by all office and art supply stores and most drug and discount stores.

### **PRIZES:**

Prizes will be awarded to Individuals in each of the categories:
