### **MY PATH TO JUSTICE**

One case that shattered my understanding of justice was that of Derrick Jamison. In 1985, he was sentenced to death for a murder he did not commit. As he shared his story, my heart sank learning how prosecutors deliberately withheld crucial evidence that would have proven his innocence. For twenty agonizing years, Jamison woke up each morning on death row, counting days stolen from his life, before his charges were finally dismissed in 2005. You could see the pain in his eyes as he recounted the death of both his parents while he was in prison. I felt not just sympathy, but a burning resolve. His story is a constant reminder of why I must pursue justice.

My name is Abigal Davis, and I am currently a senior at Tiffin University, where I will graduate with my degree in Criminal Justice in the fall of 2025. To me, the Constitution isn't simply another historical document, it represents a sacred promise of justice, fairness and unity for all Americans. Yet through my studies and personal encounters with those like Derrick Jamison, I've witnessed how this promise remains heart-wrenchingly unfulfilled for too many. Wrongful convictions, prosecutorial misconduct, and disproportionate sentencing continue to tear families apart and devastate lives across our nation. It is the weight of these injustices that fuels my unwavering passion for the law.

For me, my passion burns from a deep commitment to justice and fairness that has only grown stronger with each injustice I've witnessed. I plan to pursue my law degree at The Ohio State University, where I can gain not just knowledge, but the practical skills needed to stand effectively for those whose voices often go unheard. After earning my degree, I aim to practice as an attorney before eventually working toward my ultimate goal of becoming a judge who never forgets what justice looks like through the eyes of the vulnerable.

I am deeply committed to becoming a lawyer who stands in the breach between what our system promises and what it delivers. From an early age, I have been captivated by the power of law, not just as a system of order, but as a vital shield protecting the vulnerable and ensuring fairness in our society. While my ultimate goal is to serve as a judge. I understand that before I can sit on the bench, I must first dedicate myself to the legal profession. Lawyers stand as the last line of defense against injustice, and I aspire to join a profession that, at its best, holds itself to the highest ethical standards and never forgets human lives hanging in the balance of each decision.

One of the greatest tragedies in our society occurs when innocent lives are shattered by wrongful convictions. It tears at my soul to witness individuals robbed of decades for crimes they did not commit, or to see people receiving punishments that far exceed their offenses. Rather than allowing these realities to extinguish my hope, they have sparked my fierce determination to be the one to fight for them. The Constitution entrusts us with the

responsibility to uphold justice, and I will stand on the front lines, fighting for every person's right to fair and equal treatment under the law.

Beyond these experiences, I have been blessed to learn from the remarkable professors who have deepened my dedication to justice. Professor Curtis, a practicing lawyer, has left a mark on my heart and mind. Despite growing up surrounded by addiction, his parents struggling with substance abuse and his father and two brothers incarcerated, he refused to surrender to circumstance or to become another part of the cycle of crime. Because of educators and mentors who saw his potential when others saw only his background, he found his calling in law and has dedicated his life to making a difference. His story of resilience against overwhelming odds and his unwavering commitment to justice inspire me daily. I hope to one day serve my community with the same courage, ensuring that the law functions not just as a collection of statutes but as a living force for meaningful change in people's lives.

The Constitution represents America's most sacred promise of justice and equality for all, but wrongful convictions and systemic failures continue to take that promise for too many of our citizens. The United States possesses an exceptional judicial system, but it is ultimately up to individuals that make up this system to ensure it serves its true purpose. Through my studies at Tiffin University and my heartwrenching conversations with exonerees like Derrick Jamison, I have witnessed the devastating human cost when our system fails. These experiences have not weakened my resolve, they have ignited a fire within me and strengthened my commitment to fighting for true justice.

Every day, I strive to build a legal system that genuinely fulfills the promise of justice outlined in our Constitution. The faces of those who have suffered injustice, along with their stories, serve as a powerful reminder of why this work is so important. Additionally, individuals like Professor Curtis inspire me to recognize the profound significance of this profession. With the right mindset, I have the opportunity to help those facing injustice, and it fills me with excitement for what the future holds. This is my commitment. This is my purpose. This is my promise.
