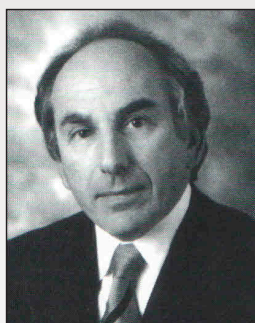

## 50TH Year Spotlight

### Douglas N. Godshall, Esq.



Doug Godshall never claims to be the smartest lawyer in his family- that is an honor he bestows on his wife, Cathy, who was his classmate at Case Western Reserve Law School. He met Cathy in Contracts class, their first year of law school. She sat a row behind him and at a break one day approached him and asked, "How do you spell commitment?" The ice was

broken and the rest is history.

Congratulations to Doug on 50 years of practicing law and thank you for your service to our country. While Doug is well known in our legal community, some may not be aware that he is a veteran. He is a Green Beret and the President of the Special Operations Association, which was also started fifty years ago by Green Berets who ran reconnaissance missions in Laos, Cambodia, and North Vietnam. His top secret unit suffered more casualties per man than any other Army unit since the Civil War. He wears a Parachute Badge, the Combat Infantry Badge, a Purple Heart, and a Bronze Star with "v", one oak leaf cluster.

Doug returned to college after his service in the Army. He intended to concentrate on a professional path, but was undecided between journalism and trial law. He never gave a thought to any other branch of the law. He joined a political campaign in Philadelphia opposing Frank Rizzo and was tasked on election day with driving lawyers to courtrooms, where they assisted citizens who were denied the right to vote or election officials who were "assisting" voters in the voting booth. Good lawyers from good firms doing good work and getting good results depending on the Judge. A very positive day for the rule of law and lawyers. He went on to become a trial lawyer representing defendants in civil cases. His experience in civil litigation has morphed into a mediation practice for the last 15 years.

As far as the biggest changes that he has witnessed in the legal profession, nothing overshadows the impact and

lingering effects of the pandemic on our profession. On March 10, Governor Dewine and COVID closed the courts, exposing what Doug sees as two huge divides in our profession. The first was technology. Seniors were afraid of Zoom but had to train quickly, with some comical results. The necessity of the situation and resorting to remote accessibility led to a sudden lack of personal interaction in our law offices and courthouses. In his opinion, we will never return to pre-COVID collegiality. Second, we have realized that the civil jury trial is on the endangered species list. Some Judges claim that COVID was the cause. Peggy Foley Jones, a sixteen year Judge in Cuyahoga County, and now a brilliant mediator and arbitrator, has written that before COVID, only 1 % of civil matters went to trial. Somewhere in our history, trying civil cases, like Doug had done so often during his 50 year career, has become a rarity.

As a litigator, Doug savored getting a good result for a client at trial. As a mediator, he gets satisfaction when he is able to help counsel and clients settle a distressing lawsuit. His advice to young lawyers is that words of encouragement or thanks to the court and counsel is always appreciated. A note is a good idea and a handwritten note, even better! Let's all send a note to Doug showing him our appreciation for all he has done and wishing him many more years of contributing to our profession.

## 50<sup>TH</sup> Year Spotlight

### Honorable Robert G. Lavery



**Let's start with how you became an attorney, give us the background.**

I graduated from Alliance High School, Bowling Green and finally Toledo Law School then I was admitted to the Ohio Bar. I was most influenced to become a lawyer from watching Perry Mason on television

growing up.

**When you first graduated law school did you immediately know what area of law you were interested in practicing? Is that the area of law you started in? If not, how did you eventually get to the area of law that you primarily practiced in during your career?**

I was first immediately interested in practicing in the area of real estate and business law in my hometown of Alliance. Later, after I held a part-time position as a municipal court prosecutor and bankruptcy trustee, my career path eventually changed.

**Did you have any legal mentors you really relied on during your career and how did they help you develop your practice?**

I was very fortunate to have Judge John Thomas mentor me in treatment programs; Judge Jack Gwin on community service, Judge Jim Williams on professionalism and Judge Charles Brown on politics.

**What was one of the greatest legal achievements you look back on from your career?**

One of my greatest legal achievements was as Judge of Alliance Municipal Court where I successfully presided over three different criminal trials with multiple defendants all reaching verdicts in a single day.

**Is there a legal opportunity you wish you had experienced during your career?**

I wish I had the opportunity to share my twelve years

experience as a retired visiting judge with other judges contemplating retirement.

**What have been the things you treasure most about the practice of law over your career?**

I will always treasure the countless relationships I developed over the past fifty years of my legal career.

**Looking back over the last 50 years, what advice would you give a new lawyer with respect to the outlook for their own career?**

Do not ignore your physical and mental health. Always be ethical and professional and remember that the legal system isn't perfect and life isn't always fair.

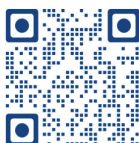
